Military Diary Case

The Military Diary documents operations carried out by Guatemalan state forces during the military dictatorship of Oscar Humberto Mejía Víctores (1983-1985).

In 1999, the document was anonymously withdrawn from the Guatemalan Military Archives and leaked to Kate Doyle of the National Security Archive. The document lays out systematic surveillance, illegal detentions, torture, sexual violence, forced disappearance, and extrajudicial killings against 183 people, including children.

The details outlined in the Military Diary have been corroborated by testimonies from both survivors and relatives of the victims. These family members have been demanding justice ever since the moment their loved ones were illegally detained.

An ongoing political crisis

Guatemala is facing a political crisis that the pandemic has exacerbated. In the most recent political scandal, Attorney General Consuelo Porras removed anti-impunity prosecutor Juan Francisco Sandoval, and replaced him with a lawyer known for persecuting anti-corruption organizers. On July 29, **Ancestral Authorities called a national strike demanding that the President and Attorney General resign and appealing for the creation of a plurinational constitutional assembly.** The uprising rejects the government's corruption and abuse of power in the name of protecting oligarchs. The whole state is co-opted. In the middle of a health crisis, the government continues stealing money allocated for vaccines, emergency aid, and health care, thereby killing its own citizens.



Families demand accountability

On May 27, twelve former military and police officials involved in the Military Diary case were arrested. These arrests were a groundbreaking advance in a case that family members have worked towards for decades. As the case moves forward, guaranteeing the safety of the families, plaintiffs, lawyers, prosecutors, and judge is a central concern and demand. The defendants have strong relationships with right-wing military organizations, private security companies, and other corrupt actors.
