2024 Accomplishments in Review

Sending a war criminal to trial required years of organizing. The cost of defending land from transnational corporations is paid in blood. ### **Accomplishments in Numbers**

NISGUA's organizing is based on strong relationships of trust with our partners, allies, and base of support. Our 2024 numbers reflect this reality.

- 700+ points of direct contact with our partners
- 50+ meetings with partners to strategize and plan actions and projects
- 50+ meetings with civil society organizations to exchange information and build collaborations
- 30+ physical visits to territories, at partner's invitations
- 18 translations of *communiqués* from our partners
- 8 political education events: webinars, workshops and teach-ins
- 8 meetings with allied accompaniment organizations

### **GUATEMALA ACCOMPANIMENT PROJECT: INTERNACIONALISTA**

NISGUA continues its decadeslong commitment to recruit, train, and assign international volunteers to accompany our local partners on the front lines of struggle. This year we have hosted 6 accompaniers: 2 outgoing, 3 incoming, and 1 short-term former accompanier.

### **IXIL GENOCIDE TRIAL**

Former Guatemalan army general, Benedicto Lucas Garcia (1981-1982), faces charges of genocide, crimes against humanity, forced disappearances, and sexual violence against the Maya Ixil People. The plaintiff of the case is NISGUA's long-time partner: The Association for Justice and Reconciliation (AJR).

While we hope that truth and justice prevail in the courts, NISGUA celebrates the AJR's historic accomplishment of keeping historical memory alive, no matter the outcome. For decades, the AJR has organized hundreds of genocide survivors, and coordinated coalitions of local and international allies, to bring cases such as this one to trial. We honor the AJR's example of dignified, long-term struggle.

- NISGUA **accompanied 90+ trial hearings** in solidarity with Maya Ixil genocide survivors who gave testimony to the atrocities that they lived through.
- International news covered the trial thanks to NISGUA's internacionalistas, increasing attention and therefore transparency in the process.
- NISGUA hosted a **webinar** with AJR to provide context for international audiences. Scan the QR code to watch the recording:



- NISGUA organized **two international delegations** to accompany the AJR and continue building a strong, wide, intergenerational network of solidarity.

  - 2. *Memory and Resistance*: This delegation hosted NISGUA partners from the Xinka community, and **activists from the United States and Puerto Rico!**

### Reflections from Patricia Gregorio de Arriaga, Xinka Parliament Authority

# "WE WERE BORN HERE, WE WILL DIE HERE, AND NO ONE WILL DISPLACE US"

For over 12 years, the Xinka people have maintained peaceful resistance against a Canadian mine that is destroying their territory. Now, they are in a community consultation process, which is the legal right of Indigenous People to decide with free, prior and informed consent, if extractive projects can be present in their territories. A Xinka authority shares her reflections:

"We are in the process of informing communities so we can carry out the consultation. Several of them have already been consulted, and 99% or 90% said they do not want the mining project in our territory. At the end of November we have to deliver all the information to the Ministry of Energy and Mines (MEM) so that they can see the documents that were written in the communities and make a decision about the mining project. We have full confidence that the project will indeed leave our territory.

NISGUA has supported the resistance from the beginning. We are very grateful that they care about us, that this information can be disseminated in the USA. The mine sends its monthly report, telling about the nice things they do. But the truth is, we who live in our territory can attest that they have acted in a bad way - they have divided the communities, there have been deaths, people have been criminalized, organizers have been displaced, there has been migration.

We are fighting against this mining project of El Escobal, in San Rafael Las Flores, and we are going to continue until the end of our lives because we were born here, we will die here and no one will displace us from our territory. [We invite] all women [to] join this struggle, to not be afraid, [because] the struggle is ours, we are already empowered, we can make our own decisions. We continue in this struggle and we thank NISGUA, who has accompanied us to this day."

### **SEEDS OF LIFE: GUATEMALA BEYOND ELECTIONS**

January through March, NISGUA published this interview series with Indigenous leaders involved in the 106-day national strike for democracy.

"Together, the interviews in this series affirm that the indefinite national strike is the blooming of seeds planted by ancestors decades ago, as well as the confirmation that springtime is on the horizon.
